

2007-2008 Milwaukee Bucks – Saz’s Rib Eat Off Contest

Official Rules

(1) **No purchase necessary to enter or win.** (2) Contest (the “Contest”) open to residents of Wisconsin and all entrants must be 18 years of age or older at the time of entry. Employees and immediate families (spouse, parents, siblings, and children) of Saz’s, Milwaukee Bucks, Inc. (the “Bucks”), the National Basketball Association and the Women’s National Basketball Association and each of its Member Teams, NBA Properties, Inc., NBA Media Ventures, LLC (collectively, the “NBA Entities”) and each of their respective parents, subsidiaries, affiliates, advertising agencies, directors, owners, employees and agents are not eligible to enter or win. Limited to one (1) entry per household during the Contest Period (defined below). (3) How to Enter and Win: During the Contest Period, completely fill out the registration form **on the Bucks Official Website at www.bucks.com** or by visiting a local Saz’s restaurant. Entry forms are also available at the Fan Assistance Center during Milwaukee Bucks home games during the Contest Period. Alternatively, entrants may print their name, address, phone number, email address and date of birth on a 3x5 in. card and mail in a postage-paid envelope to: “2007-2008 Milwaukee Bucks – Saz’s Rib Eat Off Contest”, 1001 N. 4th Street, Milwaukee, WI 53203-1312. Contest begins January 23, 2008 and ends February 15, 2008 and all entries must be received by 11:59 PM on March February 15, 2008 (collectively the “Contest Period”). Three (3) Contestants will be chosen randomly from all eligible entries received and will be notified by telephone or email by February 20, 2008. In the event a Contestant cannot be contacted or declines the prize, another Contestant will be randomly chosen from the same eligible entries. Contestants will participate in a rib-eating contest to take place on February 23, 2008 at the Bradley Center during the Bucks – Phoenix basketball game. Contests will have 2 minutes to eat as many ribs as possible. One (1) Contest Winner will be selected based on number of ribs consumed as further described by the judges before the start of the Contest. All decisions of judges will be final. Odds of winning depend on the number of eligible entries received.

(4) Prizes: Three (3) Contestants receive two (2) game tickets to the Bucks – Phoenix basketball game on February 23, 2008 (Approximate Retail Value of each prize \$_____). One (1) Contest Winner receives a trip to Chicago, IL March 29 – 30, 2008 to watch the Bucks game. Prize package includes: two (2) round trip train tickets from Milwaukee to Chicago, IL, one-night double occupancy standard hotel accommodations, \$200 spending cash (to cover food and ground transportation) and two (2) game tickets to the March 29, 2008 Bucks vs. Chicago game (Approximate Retail Value: \$_____). Winning prizes are non-transferable to any other person, including relatives or friends. Contestants are solely responsible for all applicable federal, state and local taxes and any expenses associated with the game, unless otherwise indicated. No substitution, cash equivalent or transfer of prize permitted except at the Bucks’ option for a prize of comparable or greater value. All decisions are made by the Bucks (or its participating sponsors) and such decisions final. Travel/accommodations are subject to availability and restrictions may apply. The trip and travel arrangements are made solely at the Bucks discretion. Game tickets will be in a location to be determined by the Bucks. Game times, dates and locations are subject to change and cancellation outside of the Bucks’ control. Contestants may be required to complete an Affidavit of Eligibility and Liability/Publicity Release and return same properly executed, within seven (7) days of issuance of prize(s).
